## **OFFICE UPDATES:**

#### **Incubator Center**

Mr. Rose informed the Board that Ms. Tiffani Underwood, Executive Director of West Piedmont Business Development Center would be assisting in the new industrial business incubator at Narrowflex.

### **VDOT Punch List**

Mr. Rose informed the Board that the maintenance crew had completed 14 out of the 15 problems listed on the VDOT Punch List. He estimated that approximately 75% of the items on the list have been completed by the county maintenance department. They would; however, need to obtain a water analysis from Adams Heath Engineering.

## **Primland**

Mr. Rose informed the Board that the lodge at Primland would bring new jobs into the area, and they would be working closely with Patrick Henry Community College and Virginia Tech for the training that would be necessary. Classes for the Customer Service program will be held on February 13, February 24 and March 5. Thirty-three have already responded to enter this training program. Mr. Rose stated that he would like to thank all of those involved in getting this program together including Steve Helms and Brooks Bradbury from Primland; Dr. Morris, Patrick County School System; Jerry Hughes, Patrick County Education Foundation; Tom Bishop, Patrick County Chamber; Matilda Hunsicker, Adult Ed.; and Wanda Whitlow, Workforce Investment Board.

## Broadband

Mr. Rose informed the board that the Broadband study was complete. He thanked Mr. Jim Ingram, and Mr. Roger Hayden for all the help they contributed towards this study.

## **Enterprise Zone**

Mr. Rose informed the Board that the enterprise zone application narrative was complete and things were moving forward and on schedule.

#### **OTHER BUSINESS:**

#### VA Transformer

Mr. Rose informed the Board that there were good quality applicants from the ad that was in the Enterprise for jobs with VA Transformer out of Roanoke. He informed the board that that were currently 20 positions getting ready to go into training and they anticipated 20 more jobs. Mr. Rose thanked Bill Goad, Executive. Director of Virginia Transformer; Wanda Whitlow, WIB; Angie Brown, Patrick Henry Community College; and Rhonda Hodges, Patrick Henry Community College for their assistance.

## **Entrepreneur Express/One-on-One Sessions**

Ms. Pendleton gave an update on the progress that was being made from the Entrepreneur Express that was held at the PHCC, PC Site on November 12. She informed the Board that there was success with the first one-on-one session with Sandy Ratliff of the Virginia Department of Business Assistance and that she was booked up with local businesses for the sessions that would be held on December 18, 2008. A third and positive session was held on January 22, and there is a possibility of another session being held if there is enough interest.

Ms. Ratliff stated the need for some basic internet training as well as training on basic website development and social networking to promote a business. She also stated "I seriously believe it is needed, as well as basic business management training." She suggested working with Patrick Henry Community College to see if they can could do something at the branch campus in Patrick County to help the small businesses.
