APPROVAL TO CONDUCT LAND-DISTURBING ACTIVITIES UNDER THE PATRICK COUNTY STORMWATER MANAGEMENT ORDINANCE

In compliance with and pursuant to the Patrick County Stormwater Management Ordinance, the operator of the construction activity listed below is hereby authorized to conduct land-disturbing activities in conjunction with said construction activity. All land-disturbing activities shall be carried out in accordance with the approved Stormwater Management (SWM) Plan; approved Erosion & Sediment Control (ESC) Plan; or in the case of a single-family residential structure both an ESC and SWM "Agreement in lieu of a Plan" certifications; and the Stormwater Pollution Prevention Plan (SWPPP).

Authorized discharges to surface waters of the Commonwealth, shall be in accordance the Commonwealth of Virginia General Permit VAR10 issued by the Department of Environmental Quality (a copy of which is attached hereto as evidence of project state coverage).

I further understand that personnel from the Patrick County SWM Office will inspect and monitor this project for compliance with this permit and the Virginia General Permit VAR10 both during and after construction, and that I shall grant those persons right of entry onto the property or properties at any reasonable time for the purposes of obtaining information, conducting surveys or investigations in the performance of county inspections. Further, I hereby accept full responsibility for all work performed in the fulfillment of this permit.
