- Rescue services is provided by six volunteer rescue squads with 24-hour-a-day operation. These squads are as follows: Vesta (Meadows of Dan), Ararat, Smith River (Woolwine), CCDF (Collinstown Claudville Dry Pond Five Forks), Blue Ridge (Willis Gap), and Jeb Stuart (Patrick Springs). All squads have VHF radios. All squad units are dispatched through the Sheriff's Department.

- Education is a vital key in job preparation and attainment and a top priority to Patrick County residents. An educated population not only benefits individuals but also can be an influential tool in the recruitment of well-paying high technology industries to the County.
- Patrick County Public School System operates six elementary schools, one high school. The primary schools are as follows: Blue Ridge Elementary, Hardin Reynolds Memorial Elementary, Meadows of Dan Elementary School, Patrick Spring Primary School, Stuart Elementary and Woolwine Elementary School. Pg. 5-9 – Governmental Organization

- Patrick County is governed by an elected Board of Supervisors who are chosen from five voting districts. The qualified voters of each district elect one representative for a supervisor for a four-year term with elections being held on a staggered basis in order to

provide continuum in the governing of the County. The Board meets publicly once a month.

- Voters also elect the Commonwealth's Attorney, Commission of the Revenue, Sheriff, School Board, Treasurer and the Circuit Court Clerk. The General Registrar is appointed by the Electoral Board, which is itself appointed by the Circuit Court Judge for three-year terms. The Board of Supervisors employs a county administrator, who is responsible for the day-to-day affairs of the County. Patrick County School Board became an elected board. Prior to that time, the School Board was appointed by the Board of Supervisors.

Local and Regional Planning

- The Patrick County Planning Commission has 7 members, all County citizens appointed by the Board of Supervisors. Patrick County is a member of the West Piedmont Planning District Commission, one of 21 planning districts in Virginia.
