Transportation:

Larry Cowley received an email from Carol Moneymaker, Planning Specialist/Salem District with VDOT with information updating the section of the Transportation. Larry Cowley and Cynthia Cowley will rewrite the Transportation section and present it to the planning commission for editing.

Kurt Bozenmayer presented a copy proposing a disclaimer for the Transportation Section. No action was taken.

Revise 2nd paragraph revise to – The improvements to U.S. Route 58 west of Stuart, which will involve widening this aerial roadway two four lanes, started in 2022 with a finish date of 2025, presents the possibility of greater commercial development along the 58 corridor.

Remove – A water line extension along this corridor from Stuart to Patrick Springs further increases this possibility.

Gerri Hazelwood, County Administrator emailed information to the Recreation Office for the Planning Commission to review to add Objective and Strategies for Solar in the 2021 Comprehensive Plan.

Gerri Hazelwood states: "In talking with the Mark Popovich, High Council deemed additional Objective Strategies should be added to the Comprehensive Plan regarding Solar. Should the Planning Commission so deem to adopt the Objective and Strategies as written by Mr. Popovich, a public hearing for the Planning Commission approval of the Solar Objective & Strategies written by the county attorney to amend the 2021 Comprehensive Plan. The recommendation from the Planning Commission will send to the Board of Supervisors for review and to hold a public meeting to add into the Comprehensive Plan."
