Patrick County VSMP Authority Permit (SWM-P01) General VPDES Permit for Discharges of Stormwater from Construction Activities (VAR10)

Instruction: Applicants for a VSMP Authority Permit (SWM-P01) and DEQ General VPDES Permit (VAR10) are required to pay permit fees at time of submission of a registration statement to DEQ. Applicable fees must also be paid for a notice of permit modification, notice of transfer of ownership, annual maintenance, and permit reissuance. Applications will be considered incomplete if the proper fee is not paid and will not be processed until the fee is received.

The Fee Schedule for permit action is included with this form. Fees for permit issuance or reissuance, permit maintenance, permit modification, and permit transfer are included. Once you have determined the fee for the type of application you are submitting, complete this form. Notes to Table 1:

- If the project is completely administered by the Department such as may be the case for a state or federal project or projects covered by individual permits, the “Total Fee to Be Paid by Applicant” shall be paid directly to DEQ by the applicant.
- In accordance with Section 1-15(a) of the Stormwater Management Ordinance, when a site has been purchased for development within a previously permitted common plan of development or sale, the Applicant shall be subject to fees (“Total Fee to be Paid by Applicant” column) in accordance with the disturbed acreage of their site or sites.

TABLE 2: Fees for the Modification or Transfer of a VSMP Authority General Permit for Discharges of Stormwater from Construction Activities or a VSMP Authority approved Agreement in Lieu of Plan for single-family detached residential structures.

Notes to Table 2:

- In accordance with Section 1-15(b) of the Stormwater Management Ordinance, if the general permit modifications result in changes to stormwater management plans that require additional review by Patrick County, such reviews shall be subject to the fees set out in Table 2.
- In accordance with Section 1-15(b) of the Stormwater Management Ordinance, in addition to the general permit modification fee, modifications resulting in an increase in total disturbed acreage shall pay the difference in the initial permit fee paid and the permit fee that would have applied for the total disturbed acreage in Table 1.

TABLE 3: Maintenance Fees for a VSMP Authority General Permit for the Discharge of Stormwater from Construction Activities or a VSMP Authority approved Agreement in Lieu of Plan for single-family detached residential structures.

Notes to Table 3:

- VSMP general permit coverage maintenance fees shall be paid annually to the County, by the anniversary date of general permit coverage. No permit will be reissued or automatically continued without payment of the required fee. General permit coverage maintenance fees shall be applied until a Notice of Termination is effective.

Fee Table General Notes:

- In accordance with Section 1-15(e) of the Stormwater Management Ordinance, no general permit fees will be assessed to.
 - Permittees who request minor modifications to general permits as defined in Section 1-2 of the Stormwater Management Ordinance.
 - Permittees whose general permits are modified or amended at the initiative of the Department, excluding errors in the registration statement identified by the Administrator or errors related to the acreage of the site.
- In accordance with Section 1-15(f) of the Stormwater Management Ordinance, all incomplete payments will be deemed as non-payments, and the applicant shall be notified of any incomplete payments. Interest may be charged for late payments at the underpayment rate set forth in section 58.1-15 of the Code of Virginia and is calculated on a monthly basis at the applicable periodic rate. A 10% late payment fee shall be charged to any delinquent (over 90 days past due) account. The County shall be entitled to all remedies available under the Code of Virginia in collecting past due amounts.
