## NEW BUSINESS:

Joe Bonanno, Regional Planner with West Piedmont Planning, reviewed questions from the Planning Commission.

Broadband is available in some locations of the County from CenturyLink. The County is working on further venues to make broadband more assessable to the County.

- 9) Bryce Simmons stated a grant for Healthy Patrick County Initiative with Nancy Bell, West Piedmont Health District. The grant is to expand broadband to the Rescue squads to perform basic telehealth in partnership with Free Caring Hearts and Patrick County Urgent Care.
