The Project includes furnishing all labor, material, and equipment necessary for the installation of approximately 207 linear feet of 24 inch reinforced concrete pipe, 3 each precast concrete manholes, 1 each precast concrete endwall, and all other necessary appurtenances as shown on the construction plans and as defined within the project specifications.
